

ROKU WINNING WONDERLAND SWEEPSTAKES 2024
OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. MAKING A PURCHASE WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

The Roku Winning Wonderland Sweepstakes 2024 (“Sweepstakes”) is sponsored by Roku, Inc. (“Sponsor”), 1173 Coleman Ave, San Jose, CA 95110, and is administered by Twelve Thirty, LLC (“Administrator”).

Entries submitted in an Entry Period **DO NOT** carry forward to subsequent Entry Periods. The Administrator’s computer is the Sweepstakes official clock.

2. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States who are at least eighteen (18) years old at the time of entry.
